

UOB SME Transact & Win TERMS AND CONDITIONS

United Overseas Bank (Malaysia) Bhd (Company Reg No. 199301017069 (271809-K)) ("UOB Malaysia") is running a "UOB SME Transact & Win" ("Campaign") from 15 March 2023 to 15 May 2023 (both dates inclusive), or until such other date(s) as may be determined by UOB Malaysia from time to time ("Campaign Period").

Eligibility to participate

- 1. The Campaign is open to all UOB Malaysia new and existing Business Banking customers who have Business Current Account at any UOB Malaysia branches ("Participant")
- 2. Business Current Account shall refer to any one of the following products:-
 - (a) BizCA+
 - (b) Normal Business Current Account
 - (c) BizMax
- 3. Customers shall not be eligible to participate in this Campaign if they fall within **ANY** of the following:
 - (a) whose account maintained with UOB Malaysia is delinquent or unsatisfactorily conducted as determined by UOB Malaysia.
 - (b) whose account maintained with UOB Malaysia is terminated or closed during the Campaign Period.
 - (c) who is or has becomes mentally unsound, deceased, adjudicated bankrupt (for sole proprietorship), wound up (for corporate), insolvent (for corporate) or has legal proceedings of any nature instituted against them.

Campaign Mechanics and Qualifying Criteria

- The Eligible Participant who is entitled to the Reward will be notified by UOB Malaysia via a letter delivered to the Eligible Participant / authorized person of the Eligible Participant's address in



Malaysia as reflected in UOB Malaysia's system within three (3) months after the Campaign Period ended.

- 7. The Reward will be delivered to the respective Eligible Participant's address provided by the Eligible Participant to UOB Malaysia.

UOB Malaysia shall not be obliged to give any reasons or enter into any correspondence with any person(s) on any matter concerning the Campaign and the Reward. - 20. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Participant agrees to submit to the non-exclusive jurisdiction of the courts of Malaysia.
