The UOB Presale will take place on 3 June 2026, Wednesday, from 10:00AM (MYT) to 2:00PM (MYT), or whilst stocks last ("UOB Presale).

2. Limited tickets are available for Eligible Cardmembers during the UOB Presale. UOB does not control the ticket inventory and does not guarantee



ticket availability. Tickets are subject to availability, location on a first-come, first-serve basis, and limited to the available inventory.

3. Ticket must be purchase at BookMyShow website (i.e. <https://my.bookmyshow.com/>). The purchase of Concert ticket is subject to event organiser and BookMyShow ("Ticketing Agency") terms and conditions. Eligible Cardmembers are advised to review event organiser and Ticketing Agency's terms and conditions prior to purchase subject to ticket availability.
4. Eligible Cardmembers is limited to purchase a maximum of SIX (6) tickets per transaction during the UOB Presale.
5. Payment for ticket purchase must be made with an eligible UOB Card. Completion of ticket purchase is subject to Ticketing Agency's acceptance of Visa and Mastercard, unless stated otherwise.
