

# **UOB Malaysia "App Exclusive Weekend Flash Deal"**

### **TERMS AND CONDITIONS**

United Overseas Bank (Malaysia) Bhd (Company Reg No. 199301017069 (271809-K)) ("UOB Malaysia") is organising a "App Exclusive Weekend Flash Deal" ("Campaign") from 19 April to 25 May 2025 (both dates inclusive), or until such date(s) as may be determined by UOB Malaysia from time to time ("Campaign Period").

The weekend shall mean the Saturdays and Sundays during the Campaign Period.

### Eligibility to participate

- 1. The Campaign is open to all UOB Malaysia individual customers who meet <u>ALL</u> of the following conditions:
  - (a) 18 years of age and above.
  - (b) Have not held any savings account or current account with UOB Malaysia for the past 12 months prior to the starting date of the Campaign Period.
  - (c) Primary account holder of the Participating Account
  - (d) Account(s) with UOB Malaysia are current, subsisting and not in default in any manner as may be determined by UOB Malaysia.
- 2. Customers shall not be eligible to participate in this Campaign if they fall within **ANY** of the following:
  - (a) Private Banking customers of UOB Malaysia.
  - (b) Permanent and contract employees of UOB Malaysia (including UOB Malaysia's subsidiaries and related companies) ("**Employee**").
  - (c) Individual customers whose Participating Account is held jointly with an Employee.
  - (d) Non-individual customers of UOB Malaysia.
  - (e) Whose Participating Account is pledged, charged or assigned under loan /financing facilities.
  - (f) Persons who are or become mentally unsound, deceased, adjudicated bankrupt or have legal proceedings of any nature instituted against them.
  - (g) Whose account held with UOB Malaysia is terminated or closed within the Campaign Period.
  - (h) Any account held with UOB Malaysia that is delinquent or unsatisfactorily conducted as determined by UOB Malaysia.

# **Campaign Mechanics**

- 3. Customers must fulfil the following conditions to be entitled to receive cash reward of Ringgit Malaysia Five Hundred (RM500) ("Reward"). Customers who fulfil these criteria are hereinafter referred to as "Eligible Customers".
  - a) Opens and activates a UOB One Account, Stash Account, Lady's Savings Account or ProSave Account-i ("Participating Account") via UOB TMRW app with an initial deposit (fresh funds) of minimum RM100 every Saturday and/or Sunday during the Campaign Period ("Participating Weekend Day"); and,
  - b) Becomes one of the fifteenth (15<sup>th</sup>) or every subsequent 15<sup>th</sup> Eligible Customer thereafter to complete the above condition on each Participating Weekend Day. There is a maximum of eight (8) such positions allocated for each Participating Weekend Day.

- 4. For the purpose of participating in this Campaign, all deposits must be made using Fresh Funds. The term 'Fresh Funds' means monies or funds in Ringgit Malaysia howsoever transferred, credited, or paid into the Participating Account of the Eligible Customers from other bank(s) and/or financial institution(s) through whatever means including but not limited to cash, Inter Bank Giro transfers, instant fund transfers between banks and collection and payment of cheques drawn on such other bank(s).
- 5. Funds transferred from any existing UOB Malaysia's Savings / Current / Fixed Deposit / Foreign Currency account(s) or in the form of UOB Malaysia's cheques, cashier's orders or demand drafts shall not be considered as Fresh Funds.
- 6. This Campaign shall not be valid with the following campaigns ("Other Campaigns"):
  - a. UOB Malaysia Exclusive Sign-Up Campaign.

In the event the Eligible Customer has received any rewards from other ongoing campaign(s), Eligible Customer will still be eligible to participate in this Campaign and vice versa, subject to the Terms and Conditions governing the Other Campaigns.

#### Reward

7. Eligible Customers shall be entitled to the Reward as below:

Eligible Customers are selected based on account activation* date & time and by every 15 <sup>th</sup> Eligible Customer and each subsequent 15 <sup>th</sup> Eligible Customer, ie: 15 <sup>th</sup> , 30 <sup>th</sup> , 45 <sup>th</sup> , 60 <sup>th</sup> , 75 <sup>th</sup> , 90 <sup>th</sup> , 105 <sup>th</sup> , and 120 <sup>th</sup> )  *Activation refers to the transfer of minimum initial deposit of RM100 or more to the new UOB savings account using DuitNow or Instant Transfer from another Malaysian bank's online banking platform.	Ninety six (96) unique Eligible Customers.

Each Eligible Customer will receive a maximum of one (1) Reward irrespective of the total number of Participating Account opened during the Participating Weekend Day.

## **Reward Fulfilment**

8. The Reward will be credited into the Eligible Customer's Participating Account within ninety (90) days from the end of the Campaign Period, which will be reflected in Participating Account's statement accordingly. The contents of the Participating Account's statement showing the Reward shall be treated as correct and conclusive evidence of Eligible Customer's receipt of the Reward.



- 9. UOB Malaysia reserves the right to substitute or vary the Reward at any time with prior notice for another reward which is similar or equivalent with the value of the Reward.
- 10. In the event that the Participating Account is suspended or frozen or closed for whatsoever reasons before the crediting of the Reward into the Participating Account, UOB Malaysia reserves the right to forfeit the Reward.
- 11. By participating in this Campaign, Eligible Customer agree and consent to UOB Malaysia to publish or display the Eligible Customer's name for advertising and publicity purposes relating to the Campaign. No fees or any form of compensations will be paid to the Eligible Customers for any of the foregoing.

### **General Terms and Conditions**

- 12. The Eligible Customers agree to be bound by these terms and conditions and the Terms and Conditions Governing Accounts and Services (Conventional Banking) and Terms and Conditions Governing Islamic Accounts and Services (collectively as "Generic T&Cs"), including any amendments or variations to it and the decision of UOB Malaysia in connection with any matter relating to the Campaign shall be final, conclusive and binding on the Eligible Customers. If there is any inconsistency between this terms and conditions and the terms and conditions listed above in relation to this Campaign, this terms and conditions shall prevail.
- 13. Eligible Customers shall seek clarification from UOB Malaysia's authorized representative if there are any terms and conditions that the Eligible Customers do not understand.
- 14. Unless specifically mentioned in this terms and conditions, this Campaign is not valid with other UOB Malaysia's campaign and no other special, additional, preferential rates and/or reward shall be given to the Eligible Customers in addition to this Campaign.
- 15. The records of transactions maintained by UOB Malaysia and UOB Malaysia's decision in all matters (including but not limited to any dispute arising therefrom) relating to this Campaign shall be final, conclusive and binding on the Eligible Customers. Save for manifest error (for example, discrepancies in transactions) or fraud, UOB Malaysia will not be obliged to entertain enquiries or appeals in respect of this Campaign.
- 16. UOB Malaysia shall not be responsible nor shall accept any liabilities of any nature and however arising or suffered by the Eligible Customers or any third parties resulting directly or indirectly from this Campaign, unless due to UOB Malaysia's gross negligence or wilful misconduct specifically related to this Campaign.
- 17. Deposits placed with UOB Malaysia are protected by Perbadanan Insurans Deposit Malaysia ("PIDM") up to Ringgit Malaysia Two Hundred Fifty Thousand (RM250,000) for each depositor. Eligible Customers may obtain a copy of the PIDM brochure from any of UOB Malaysia's branches. UOB Malaysia is a member of PIDM.
- 18. To the fullest extent permitted by law and unless due to UOB Malaysia's gross negligence or wilful misconduct, UOB Malaysia expressly excludes and disclaims any representations, warranties or endorsements, expressed or implied, written or oral, without limitation to those published in any mass media, marketing or advertising materials, including but not limited to, any warranty of quality, merchantability or fitness for a particular purpose.





- 19. UOB Malaysia shall not be liable for any misinterpretation or misrepresentation of facts by any unauthorized third party in respect of the Campaign offered and published in any media, marketing, or advertising materials.
- 20. To the fullest extent permitted by law, UOB Malaysia reserves the right to cancel, withdraw, suspend, extend or terminate the Campaign prior to the expiry of the Campaign Period, wholly or in part, at any time, with prior notice. For the avoidance of doubt, cancelation, withdrawal, suspension, extension or termination by UOB Malaysia of the Campaign shall not entitle the Eligible Customers to any claim or compensation against UOB Malaysia for any and all losses or damages suffered or incurred by the Eligible Customers whether as a direct or indirect result of such cancelation, withdrawal, suspension, extension or termination, save for UOB Malaysia's gross negligence or willful misconduct specifically related to this Campaign.
- 21. To the fullest extent permitted by law, UOB Malaysia reserves the right to add, delete, suspend or vary the Campaign terms and conditions, from time to time, wholly or in part by providing prior notice to the Eligible Customers via posting on UOB Malaysia's website, displaying a notice at any of UOB Malaysia's branches and/or a statement insert in the Statement of Account or any other manner as determined by UOB Malaysia from time to time.
- 22. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the non-exclusive jurisdiction of the courts of Malaysia.
