 ("UOBM") together with AUSED CONSULTANTS SERVICES SDN. BHD. (Company No. 0440653A) ("AUG") entered an agreement, whereby AUG will provide benefits to UOBM's Clients (defined below) from 1 July 2022 to 30 June 2027 (both dates inclusive).

## **Eligibility**

 Existing Privilege Banking and Wealth Banking Clients ("Client" individually and collectively "Client(s)")

#### **Mechanics**

- 3. AUG will provide the Clients the following services as stated below.
  - i) Arrangement of Higher Education
    - Provide free advice and guidance in exploring study options at selected education institutions in Australia, United Kingdom, United States of America, Switzerland, Ireland, Singapore and Malaysia, including but not limited to providing assistance in application and obtaining acceptance into an institution of choice represented by AUG.
  - ii) Overseas Institution Application Fee Waivers
    - AUG will waive any Overseas Institution Application Fees for selected universities/ institutions, that may be incurred by the Client, where applicable (For e.g. UCAS for UK Institutions and application fees for selected Australian Universities).
  - iii) Private One-to-One Consultation and Pre-departure Briefing

    - AUG will assist in student accommodation arrangement at study destinations. Charges of such student accommodation shall be borne by the Client.
  - viii) Travel Arrangement
    - AUG will provide assistance in visa arrangement and/or extensions.
  - ix) Private One-to-One Consultation on Australian Permanent Residency and Visa
    - AUG will provide the Clients with private one-to-one consultation and free initial assessment on Australian Permanent Residency and Visa. A special discounted



professional fee will be provided to the Clients should they decide to take up the Services.

- x) Consultation with a qualified MBTI Counsellor
  - AUG will provide a FREE 30-minute private one-to-one consultation to students if required. A special discounted professional fee will be provided to the Clients should they decide to take up the further consultation service.
