# UOB Malaysia Wealth Banking Sign Up for Maxis Subscribers Campaign Terms and Conditions

 United Overseas Bank (Malaysia) Bhd [Company Reg No. 199301017069 (271809-K)] ("UOB Malaysia") is running a Wealth Banking Sign Up for Maxis Subscribers H2 2022 Campaign ("Campaign") from 1 July 2022 until 31 October 2022 (both dates inclusive) or such date(s) as may be determined by UOB Malaysia from time to time ("Campaign Period").

# Eligibility

- 2. The Campaign is open to all UOB Malaysia individual customers, who are also Maxis subscribers with MyMaxis Biz, MyMaxis, Hotlink Flex and Hotlink Red mobile application ("Eligible Customers").
- 3. The following persons shall not be eligible to participate in the Campaign:
  - (a) Existing UOB Malaysia Wealth Banking ("WB") and Privilege Banking ("PV") individual customers.
  - (b) Sole-proprietorship, partnership, charitable/non-profit organisation/societies, corporate and commercial customers
  - (c) Permanent and contract employees of UOB Malaysia (including UOB Malaysia's subsidiaries and related companies)
  - (d) Persons who are or become mentally unsound, deceased, adjudicated bankrupt or have legal proceedings of any nature instituted against them

## Sign Up Mechanics and Conditions

- 4. In order to participate in this Campaign, the Eligible Customers must comply with the following during the Campaign Period ("Qualification Criteria"):
  - (a) Log in to their MyMaxis Biz, MyMaxis, Hotlink Flex or Hotlink Red mobile application ("Eligible App") and download the UOB Malaysia's deal from the Eligible App;
  - (b) Redeem the UOB Malaysia's deal at any UOB Malaysia branch and
  - (c) Eligible Customers must satisfy any one of the following criteria as following

5. "Fresh Funds" means moneys or funds in Ringgit Malaysia howsoever transferred, credited or paid into the accounts of the Eligible Customers from other bank(s) and/or financial institution(s) through whatever means including but not limited to cash, Inter-Bank Giro transfers, Interbank Instant Transfer, collection and payment of cheques drawn on such other bank(s) and where such moneys or funds paid or credited into the account(s) of the Eligible Customers are utilized by the Eligible Customers to make placements pursuant to the terms and conditions herein within seven (7) business days after such moneys or funds have been paid or credited into the account(s) of the Eligible Customers. Funds transferred from any existing UOB Malaysia savings/current/fixed deposit/Foreign Currency account(s) or in the form of UOB Malaysia cheques, cashier's orders or demand drafts are not Fresh Funds and would not be eligible for this Campaign.

- 6. "AUM" refers to deposits and investments which include savings accounts, current accounts, fixed deposit accounts, unit trusts, retail bonds, long term structured investments, short term structured investments and dual currency investments (or such deposits and investments as UOB Malaysia may decide from time to time).
- 7. During the Campaign Period, the Eligible Customer who satisfies the Qualifying Criteria for WB is eligible to the receive the Welcome Gift as illustrated below:-

- There are one hundred (100) units of Welcome Gift which will be given on a first-come, first-served basis, subject to availability of the Welcome Gifts. Each Eligible Customer is allowed to redeem one (1) Welcome Gift only throughout the Campaign subject to availability and only the primary accountholder will be entitled to redeem the Welcome Gift.
- 9. In the event that the investments in any one of the Unit Trust ("UT") are cancelled by the Eligible Customers during the respective "cooling off" right provided by the UT fund, the Eligible Customers shall not be entitled to the Welcome Gift.

UT fund "cooling off right" means:-

- (a) Any customer investing for the first time in any UT fund with UOB Malaysia will be entitled to exercise the "cooling off" right only once. The "cooling off" right is not applicable for any subsequent investment by the same customer in UT fund with UOB Malaysia.
- (b) If the Eligible Customers elect not to continue with the investment in the eligible UT fund within the "cooling off" period, the Eligible Customers will receive the refund of the investment amount in the eligible UT fund and the UT fund service charge that was paid.
- (c) The "cooling off" period is a period of six (6) Business Days commencing from the date of receipt of the UT fund application by UOB Malaysia.

"Business Day" shall mean a day on which UOB Malaysia is open for business in Kuala Lumpur, Malaysia.

- 10. UOB Malaysia reserves the right to approve or reject any application for WB and/or UOB Malaysia account opening by the Eligible Customers without incurring any liability to the Eligible Customers.
- 11. The Campaign is not valid with any other campaigns/promotions of UOB Malaysia and no other special, additional or preferential rates shall be given under the Campaign.

## Welcome Gift Fulfilment

- 12. The Eligible Customers or the authorised person of the Eligible Customers will be notified of their Welcome Gift by telephone eight (8) weeks after his / her WB sign up month, in accordance with this terms and conditions by using the latest telephone numbers furnished to UOB Malaysia as shown in UOB Malaysia's records. The Eligible Customers are entitled to collect the Welcome Gift upon receipt of the notification of the Welcome Gift from UOB Malaysia at the branch where the Eligible Accounts are maintained.
- 13. Welcome Gift fulfilment:
  - (a) Eligible Customer must collect the Welcome Gift which will be available for collection at the UOB Malaysia branch where the Eligible Customer are maintained by the Eligible Customer

within twelve (12) weeks from the end of the Campaign Period, at their own cost and expenses. If the Eligible Customer is not able to collect the Welcome Gift within twelve (12) weeks starting from the end of the Campaign Period, UOB Malaysia shall not entertain any requests for courier of the Welcome Gift.

- (b) Collection of the Welcome Gift by Third Party will be done at the respective branches with prior agreement by the Eligible Customer;
- (c) UOB Malaysia shall not be obligated to replace any damaged or stolen Welcome Gift. The Welcome Gift is neither transferable nor exchangeable for cash, credit or other goods, in part or in full;
- (d) UOB Malaysia reserves the right to substitute or vary the Welcome Gift with alternative gift/voucher of similar value at any time with prior notice;
- (e) The Welcome Gift is subject to the terms and conditions of the organisation(s) whose products are given out as Welcome Gift in this Campaign; and
- (f) UOB Malaysia is not affiliated with any of the organisations whose products are given out as Welcome Gift in this Campaign.
- (g) UOB Malaysia makes no representation or warranties with respect to the Welcome Gift, and in particular, makes no warranties with the respect to the quality of the Welcome Gift or its suitability for any purpose;

- UOB Malaysia shall not be held liable for consequential loss or damage, of any nature and however arising, any mishaps, injuries or accidents that may occur in the usage of the Welcome Gift received in this Campaign; and
- (j) UOB Malaysia is not in any way endorsing, sanctioning, approving or supporting the use of the Welcome Gift's brand or the type of product.
- 14. Any props, accessories or equipment featured together with the Welcome Gift in all printed materials, website or UOB Malaysia branches are for decorative purposes only and shall not form part of the Welcome Gift.
- 15. Eligible Customers are advised to examine the Welcome Gift upon receipt. The Welcome Gift have not been certified by UOB Malaysia and under no circumstances shall the inclusion of the Welcome Gifts in this Campaign be construed as an endorsement or recommendation of such Welcome Gifts by UOB Malaysia. If any person is subsequently found not to be eligible to participate in this Campaign, or has failed to satisfy any of the conditions herein, UOB Malaysia reserves the right to recover the full value of the Welcome Gift redeemed by that person, or to forfeit that person's entitlement to the Welcome Gift if they have not been redeemed. If any person redeems any Welcome Gift which that person is not eligible to receive, UOB Malaysia reserves the right to recover the full value of the Welcome Gift from that person. If any person fails to redeem the Welcome Gift within the stipulated deadline (if any and where applicable), UOB Malaysia reserves the right to forfeit that person's entitlement to the Welcome Gift. No person shall be entitled to any payment or compensation from UOB Malaysia, should any Welcome Gift be forfeited.

## **General Terms and Conditions**

17. By participating in this Campaign, the Eligible Customers agree to be bound by these terms and conditions, the Terms and Conditions Governing Accounts and Services (Conventional Banking), Terms and Conditions Governing Islamic Accounts and Services, Wealth Banking Membership Terms and Conditions and Privilege Banking Membership Terms and Conditions (collectively "T&C Governing Accounts and Services") including any amendments or variations to it and the decision of

UOB Malaysia in connection with any matter relating to the Campaign shall be final, conclusive and binding on the Eligible Customers. If there is any inconsistency between these terms and conditions and the T&C Governing Accounts and Services, these terms and conditions will prevail.

- 18. Customers shall seek clarification from UOB Malaysia's authorized representative if there are any terms and conditions that the customers do not understand.
- 19. Deposit placements are protected by Perbadanan Insurans Deposit Malaysia ("PIDM") up to Ringgit Malaysia Two Hundred Fifty Thousand (RM250,000) for each depositor. Eligible Customers may obtain a copy of the PIDM brochure from any of UOB Malaysia's branches. UOB Malaysia is a member of PIDM.
- 20. Investments in UT Funds, retail bond, long term structured investment, short term structured investment and dual currency investment are not protected by PIDM.
- 21. UOB Malaysia shall not be responsible nor shall accept any liabilities of any nature and however arising or suffered by the Eligible Customers resulting directly or indirectly from this Campaign and/or the Welcome Gift, unless due to UOB Malaysia's gross negligence or willful misconduct specifically related to this Campaign and/or the Welcome Gift.
- 22. UOB Malaysia shall not be liable for any misinterpretation or misrepresentation of facts by any unauthorized third party in respect of the Campaign and/or the Welcome Gift published in any mass media, marketing or advertising materials.
- 23. To the fullest extent permitted by law, UOB Malaysia expressly excludes and disclaims any representations, warranties or endorsements, express or implied, written or oral, without limitation to those published in any mass media, marketing or advertising materials, including but not limited to, any warranty of quality, merchantability or fitness for a particular purpose in respect of this Campaign and the Welcome Gift.
- 24. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and the other materials relating to or in connection with the Campaign, these terms and conditions shall prevail.
- 25. UOB Malaysia reserves the right to cancel, withdraw, suspend, extend or terminate the Campaign prior to the expiry of the Campaign Period, wholly or in part, at any time, with prior notice. For the avoidance of doubt, cancelation, withdrawal, suspension, extension or termination by UOB Malaysia of the Campaign shall not entitle the Eligible Customers to any claim or compensation against UOB Malaysia for any and all losses or damages suffered or incurred by the Eligible Customers whether as a direct or indirect result of such cancelation, withdrawal, suspension, extension, extension or termination.
- 26. UOB Malaysia reserves the right to add, delete, suspend or vary the Campaigns terms and conditions, from time to time, wholly or in part by providing prior notice to the Eligible Customers via posting on UOB Malaysia's website, displaying a notice at any of UOB Malaysia's branches and/or a statement insert in the Statement of Account or any other manner as determined by UOB Malaysia from time to time.
- 27. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the non-exclusive jurisdiction of the courts of Malaysia.
