

## Terms and Conditions

### UOB “Bandar Bukit Tinggi Branch Opening Deposits Promotion” Terms and Conditions

*United Overseas Bank (Malaysia) Bhd (Company No. 271809-K) (“UOB Malaysia”) is running a “Bandar Bukit Tinggi Branch Opening Deposits Promotion” (“Promotion”) from 3 May 2021 to 31 July 2021, (both dates inclusive) or such other dates as may be determined by UOB Malaysia from time to time (“Promotion Period”).*

## Eligibility

1. This Promotion is open to all new and existing UOB individual customers (“Eligible Customers”) who open a new savings account at UOB Bandar Bukit Tinggi during Promotion Period only (“Participating Account”). For avoidance of doubt, Participating Account(s) refers to the following:
  - a) ONE Account;
  - b) Stash Account; and
  - c) Lady’s Savings Account
  
2. The following persons shall not be eligible to participate in this Promotion:
  - 2.1. Sole-Proprietorship, Partnership, Charitable/Non Profit Organization/Societies, Corporate and Commercial Customers;
  - 2.2. UOB Malaysia Private Banking Customers;
  - 2.3. Persons who are or become mentally unsound, deceased, adjudicated bankrupt or have legal proceedings of any nature instituted against them;
  - 2.4. Whose Participating Account(s) held with UOB Malaysia is terminated or closed within the Promotion Period;
  - 2.5. Any Participating Account held with UOB Malaysia that is delinquent or unsatisfactorily conducted as determined by UOB Malaysia; and/or
  - 2.6. All employees (including permanent, contract or temporary employees) of UOB Malaysia, UOB’s subsidiaries and UOB’s related companies.

## Promotion Mechanics and Conditions

3. During the Promotion Period, the Eligible Customers shall open a new Participating Account with minimum deposits of two thousand Ringgit Malaysia (RM2,000) (“Minimum Deposit Amount”) to be eligible to receive one unit of Glass Bottle (“Gift”), subject to availability.
  
4. There is a total of five hundred (500) units of Gift under this Promotion which will be given on a first-come, first-served basis. In the event that Gift is fully redeemed before the Promotion

Period, a notification shall be posted on the UOB Malaysia website or any other manner as may be determined by UOB Malaysia from time to time.

5. During the Promotion Period, each Eligible Customer is only entitled to a maximum of one (1) unit of Gift.
6. Minimum Deposit Amount must be made using "New Funds".
  - 6.1 "New Funds" are funds which are newly transferred and credited to UOB Malaysia account with no more than 7 business days;
  - 6.2 Eligible Customer transfers from his/her account with other banks into his/her UOB savings account(s); and/or
  - 6.3 A third party into the Eligible Customer's UOB savings account(s).
7. Funds from the redemption of unit trust funds will be considered as New Funds.
8. Funds transferred between the Eligible Customer's existing UOB savings / current / fixed deposit / foreign currency account(s) or in the form of UOB cheques, cashier's orders or demand drafts will not be considered as New Funds.

#### **Terms and Conditions for the Gifts**

9. The Eligible Customers may collect the Gift after they open Participating Account at UOB Bandar Bukit Tinggi Branch only during the Promotion Period.
10. Picture(s) of the Gift(s) shown in any advertising, promotional, publicity and other materials relating to or in connection with this Promotion is/are solely for illustration purposes only and may not depict the actual colour, or size of the Gift(s) and does not include any optional props, accessories or equipment featured.
11. In the event of joint accountholders of the Participating Account, the Gift shall be given to the primary accountholder only.
12. The Gift is subject to the following conditions:
  - 12.1. Collection of the Gift will be at the Bandar Bukit Tinggi Branch by the Eligible Customers at their own cost and expense, and UOB Malaysia shall not entertain any requests for courier of the Gift.
  - 12.2. UOB Malaysia shall not be obliged to replace any damaged or stolen Gift. The Gift is neither transferable nor exchangeable in part or in full for cash or other goods.

- 12.3. UOB Malaysia makes no representation or warranties with respect to the Gift, and in particular, makes no warranties with respect to the quality of the Gift or their suitability for any purpose.
- 12.4. UOB Malaysia is not affiliated with the organisation whose products are given out as the Gift in this Promotion.
- 12.5. UOB Malaysia reserves the right to substitute or vary the Gift at any time with prior notice with any other item of similar value.
- 12.6. UOB Malaysia is not liable for any defects of or dissatisfaction with the Gift.
- 12.7. The Gift is subject to the terms and conditions of the organisation(s) whose products are given out as Gift in this Promotion.
- 12.8. The Gift has not been certified by UOB Malaysia and under no circumstances shall the inclusion of the Gift in this Promotion be construed as an endorsement or recommendation of such Gift by UOB Malaysia. Eligible Customers are advised to examine the Gift upon receipt. If the Eligible Customers are dissatisfied with the Gift or its quality, the Eligible Customers shall directly seek recourse with the respective vendors of the said Gift.

#### **General Terms and Conditions**

13. By participating in this Promotion, the Eligible Customers agree to be bound by these terms and conditions and the Terms and Conditions Governing Accounts and Services (Conventional Banking) (collectively as "Generic T&Cs") including any amendments or variations to it and the decision of UOB Malaysia in connection with any matter relating to the Promotion shall be final, conclusive and binding on the Eligible Customers. If there is any inconsistency between these terms and conditions and the Generic T&Cs, these terms and conditions shall prevail.
14. This Promotion is not valid with other UOB Malaysia's promotion and no other special, additional, preferential rates and/or gift shall be given to the Eligible Customers in addition to this Promotion.
15. The record of deposit transactions maintained by UOB Malaysia and UOB Malaysia's decision in all matters (including but not limited to any dispute arising therefrom) relating to this Promotion shall be final, conclusive and binding on the Eligible Customers. UOB Malaysia shall not be obliged to give any reason or entertain any correspondence with any person(s) or any party(ies) on any matter concerning this Promotion.
16. To the fullest extent permitted by law and unless due to UOB Malaysia's gross negligence or willful misconduct, UOB Malaysia expressly excludes and disclaims any representations, warranties or endorsements, expressed or implied, written or oral, without limitation to those published in any mass media, marketing or advertising materials, including but not limited to,

any warranty of quality, merchantability or fitness for a particular purpose in respect of this Promotion.

17. UOB Malaysia shall not be liable for any misinterpretation or misrepresentation of facts by any unauthorized third party in respect of the Promotion offered and published in any media, marketing or advertising materials.
18. UOB Malaysia shall not be responsible nor shall accept any liabilities of any nature and however arising or suffered by the Eligible Customers or any third parties resulting directly or indirectly from this Promotion, unless due to UOB Malaysia's gross negligence or willful misconduct specifically related to this Promotion.
19. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and the other materials relating to or in connection with the Promotion, these terms and conditions shall prevail.
20. Deposit products are protected by Perbadanan Insurans Deposit Malaysia ("PIDM") up to Ringgit Malaysia Two Hundred Fifty Thousand (RM250,000) for each depositor. Eligible Customers may obtain a copy of the PIDM brochure from any of UOB Malaysia's branches. UOB Malaysia is a member of PIDM.
21. UOB Malaysia reserves the right to cancel, withdraw, suspend, extend or terminate the Promotion prior to the expiry of the Promotion Period, wholly or in part, at any time, with prior notice. For the avoidance of doubt, cancellation, withdrawal, suspension, extension or termination by UOB Malaysia of the Promotion shall not entitle the Eligible Customers to any claim or compensation against UOB Malaysia for any and all losses or damages suffered or incurred by the Eligible Customers whether as a direct or indirect result of such cancellation, withdrawal, suspension, extension or termination, unless due to UOB Malaysia's gross negligence or willful misconduct specifically related to this Promotion.
22. UOB Malaysia reserves the right to add, delete, suspend or vary the Promotion terms and conditions, from time to time, wholly or in part by providing prior notice to the Eligible Customers via posting on UOB Malaysia's website, displaying a notice at any of UOB Malaysia's branches and/or a statement insert in the Statement of Account or any other manner as determined by UOB Malaysia from time to time.
23. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the non-exclusive jurisdiction of the courts of Malaysia.
