UOB VISA CREDIT CARD GRABPAY TOP UP PROMOTION TERMS AND CONDITIONS

Promotion Eligibility

- 1. This Promotion is open to all eligible principal and supplementary UOB Visa Credit Cardmembers who hold a UOB Visa Credit Card issued in Malaysia ("Card") with the below conditions:
 - (a) whose accounts with UOB are current, subsisting and not in default in any manner as may be determined by UOB; and
