

**UOBM VISA-HOTELS.COM PROMOTION
TERMS & CONDITIONS
UOBM VISA CREDIT CARD ("CARD")**

Eligibility

1. United Overseas Bank (Malaysia) Bhd (271809-K) ("UOBM") VISA-Hotels.com Promotion ("Promotion") is open to all eligible principal and supplementary UOBM Visa Credit Cardmembers ("Cardmembers") whose account(s) are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.
2. This Promotion is only applicable to UOBM Visa Credit Cards issued in Malaysia.
3. The following shall not be eligible for the Promotion:-
